## **Covid 19 Update**

To ensure the ongoing safety of yourselves, other clients, our vets, to testers, foot trimmer, vet tech and support staff, we ask that you help us by taking the following measures to reduce the spread of Covid-19 and keep our veterinary team supporting your businesses and providing essential services:

### **Medicines Orders**

- We have acquired a large safety net of stock in the practice to avoid shortages. We will maintain this excess of stock so that farms do not need to stockpile supplies please order normal amounts
- Ring all orders into the office a minimum of 3 days ahead we are now receiving deliveries every 48 hrs rather than every day and vets will be visiting the practice less often to collect your orders
- For medicine collection, please do not enter reception. Please ring the office from the carpark when you arrive, and your order will be placed outside the front door to avoid immediate contact

### **Farm Visits**

- We will maintain all routine and emergency calls if we experience staffing shortages in the future, this may not be your usual vet but one of the team will get to you
- If you or anyone on farm is unwell, in advised self-isolation or social distancing, please make us aware before we arrive on farm so that we can make the best decision to reduce risks for everyone
- We will continue to use our usual protective equipment and practice strict hygiene and biosecurity measures such as disinfecting between visits and wearing disposable gloves
- We will also be using antiseptic hand gel between farms
- Please always practice social distancing no hand shaking, passing equipment and stand 2 metres apart from other people. Please have essential staff only on farm to avoid increasing risks
- Unfortunately, there will be no meetings until it is safe to do so
